Empower Illinois Update: Deanne B., Bobby S.

- Empower expired
- One more chance in May 2024
- CTU opposes the program
- Trade unions, police unions, private schools, charter schools, selective enrollment schools oppose CTU
- Local Catholic schools have closed due to lack of Empower funding
- Teachers' Unions are one of the largest political contributors to elected officials.
- Teachers' Unions are refusing to support elected officials who supported the bill.

- Several parent attendees expressed concerns about bullying behavior by other students directed at their children, citing specific examples and requesting more consistency in application of the discipline policy.
