- Admissions
  - o 302 current students with more interviews scheduled.
  - o 15 families, 28 students did not return to TCS.
    - Shawn asked rationale moving, financial
  - o 37 new families with 43 new students

#### **Director of Education Report: Rachel W.**

- New Middle School ELA Curriculum Lauren H. loves the curriculum
  - o Continuation of 2<sup>nd</sup>-5<sup>th</sup> grade material.
  - o Includes grammar and writing units.
  - o Also using literature from previous teacher.
  - o Jonas B. shared that local high school English teachers were impressed with TCS students' preparation for high school English.
- Iowa single subject assessment will be administered this Friday.
  - Math and English tests only
  - Tests provides benchmarks and National Percentile Ranking
- Rachel shared Iowa Testing Scores and discussed results.
- Accreditation
  - o Teachers need to be ACSI certified. Rachel will work with teachers to obtain this.
    - If a teacher is State certified and certificate is up to date, that will qualify for certification along with a Biblical Philosophy of Education and Bible hours
    - In October, teachers will bring in their certification materials for Rachel to analyze and determine how many ACSI certifications will be needed.
    - 80% of teachers need to be certified.
    - Jon and Rachel will obtain Director of Curriculum and Head of School certifications through ACSI.
    - Spanish facilitator will not need certification. In three years she will have to get her Christian Philosophy of Education and Bible hours.
- 24 laptops have arrived for 5<sup>th</sup> grade for 2025-2026 school year. There is enough extra from 2024-2025 school year for all 5<sup>th</sup> grade students to have a laptop next year.
  - $\circ$  We are on a 1-year cycle of getting new laptops for  $5^{th}$  grade.

- Mrs. Goral is having a great first year experience at TCS.
  - o She feels supported and has loved her new teaching job.
  - o 12 full day and 4 half day students.
  - o Rachel encouraged her to always reach out when she needs help.

  - o Students have been respectful.
